

  - Conflicts with tax authorities: personal income tax, company income tax, moral persons tax and non-resident tax, VAT, gift and estate tax
- Labour and social mediation:
  - o Labour mediation for labour conflicts (federal and regional regulations)
  - Social mediation for interpersonal, group or structural conflicts in a variety of community settings; workplace conflicts in a team, between subordinate and supervisors, etc.
