### Occupational pension entitlements overview now available online

The [www.mypension.be](http://www.mypension.be) website allowed the public to verify their legal pension entitlements. The MyPension platform now allows individuals to consult their occupational pensions online.

The overview is based on information uploaded in DB2P (database occupational pensions). It currently indicates the status of occupational pensions built up as an employee and/or as self-employed at 1 January 2016, and will be updated on an annual basis.

The online file provides an overview of pension reserves and projected occupational pension to be received at retirement. Furthermore, as far as is foreseen in the occupational pension plan, the amount to be distributed upon death before retirement and the additional risk coverages, such as disability and orphan annuities, are also included.

This initiative will increase transparency and will provide a better overview of occupational pensions to which individuals are entitled, especially for those who have built up an occupational pension with several employers or companies during their career.

With this additional information now becoming available, companies are encouraged to review their employee benefits communications and update these where needed.
